- ✓ Obstetrical Education Program or equivalent education or willingness to complete (within timeframe designated by employer);
- ✓ Successful completion of NRP or willingness to complete (within timeframe designated by employer);
- ✓ Breastfeeding education/course;
- ✓ ACLS, TNCC and Medevac courses are considered an asset;
- ✓ Current certification in Basic Life Support (CPR);
- ✓ The successful applicant will be required to submit a satisfactory certificate of conduct;
